Community Goal/Result

Community Building

Purpose

Recognize outstanding residents for their contributions to the Brisbane community.

Recommendation

Review and discuss the nominations received for the annual Volunteer and Youth Volunteer of the Year Awards and select recipients.

Background

Each year, the City recognizes a Brisbane resident as its Volunteer of the Year, and a minor as the Youth Volunteer of the Year. These awards are bestowed upon dedicated community members who have demonstrated ongoing commitment to the City of Brisbane. They act with the purpose of community in mind and give selflessly to others while contributing to the high quality of life for Brisbane residents.

In the past, the selection committee has utilized the following criteria to guide their decision-making process:

Applicants must fulfill at least 3 of the following requirements to qualify for Volunteer of the Year:

- a. Consistent and ongoing service to the community spread over the course of many years/decades; a "lifetime achievement" type award.*
- b. Extensive and significant volunteer service in a particular area/field.*
- c. Volunteering across a variety of purposes and community groups.*
- d. Selfless commitment, giving for the betterment of the community and not for personal recognition or gain.*
- e. Inspires others to volunteer.*
- f. Takes the initiative to enhance the city.*

Discussion

All attendees will receive a confidential copy of the nominations received this year as well as a list of past (non-awarded) nominees. The selection committee is asked to consider all of the nominations and to select a recipient(s). The awards will be announced at the Annual Day in the Park event on October

5th, 2024 and the recipient(s) will be invited to a future Council Meeting to receive a formal proclamation.
