PUBLIC HEARING

- L.** Consider Introduction of an Ordinance Amending Brisbane Municipal Code Chapters 15.10, 17.02, 17.12, 17.16, 17.32, 17.34, And 17.43 to Amend Regulations Pertaining to Accessory Dwelling Units and Junior Accessory Dwelling Units

(This item is for a Zoning Text Amendment 2025-RZ-02; Citywide; Zoning Text Amendments to update the City’s existing Accessory Dwelling Unit regulations to comply with current State law; and finding that this project is statutorily exempt from environment review under CEQA Guidelines Section 15282(h) because it involves adoption of an ordinance regarding second units in single-family and multifamily residential zones; City of Brisbane, applicant.)

Community Development Director Swiecki reported that this draft Ordinance is being introduced to comply with state regulations pertaining to accessory dwelling units and junior accessory dwelling units. State law establishes a minimum height limit of 18 feet for detached ADUs within a half mile radius of “major transit stops” as defined by the state, which is 2–feet taller than the otherwise state–established height minimum of 16 feet. However, the Planning Commission recommended the adoption of a singular maximum height limitation of 18 feet for detached ADUs citywide. It was the Commission’s belief that a uniform standard would be more equitable than utilizing the State’s language which would allow some detached ADUs to be two feet taller than other ADUs, even within the same zoning district or on the same street.

After council questions, Mayor Lentz opened the public hearing.

Michele Salmon commented she is not in support of a singular maximum height limitation of 18 feet for detached ADUs citywide because this will mean two-story ADUs.

Councilmember O’Connell made a motion, seconded by Councilmember Davis, to close the public hearing. The motion was carried unanimously by all present.

NEW BUSINESS

M. Review and Consider Approval of the Complete Streets Safety Committee's Recommendation to Implement Full Street Closures in the Downtown Area on the Evening of Halloween, October 31, 2025

(The fiscal impact of this item will depend on Council's direction.)

Police Commander Garcia reported that this pilot program was recommended by the Complete Streets Safety Committee (CSSC). The CSSC recommends that the City Council approve a full hard closure of Mariposa, Monterey, and Mendocino Streets, which would also close San Bruno Avenue between San Francisco Avenue and Mendocino Streets as well as San Francisco Avenue from San Bruno Avenue to Mariposa Street, from 5PM to 9 PM on Halloween. The CSSC further recommends that no community surveys or voting be required before implementation and that immediate and robust public messaging be initiated to notify residents and visitors well in advance

After council questions, the following members of the public made comments in support of the full street closures: Sarah Mills, Chris Flowkowski, Michele Salmon, Emily Wirowek, Jessica Aloft, Shalena, Paul Bouscal, and an Anonymous speaker.

Council had a discussion and directed staff to do full road closures from San Bruno Avenue and the "web" streets from Mariposa to Klamath between Alvarado and Visitacion Avenue from 6-8 P.M. on Halloween, October 31, 2025, with an emphasis on safety, volunteer outreach, signage, communications plan and more parking options.

N. Consider Adoption of City of Brisbane and GVMID Resolutions Approving Tier 2 Drought Response Implementation Plan Pursuant to Section 3.11C of the Amended and Restated Water Supply Agreement and Approving an Amendment to the Amended and Restated Water Supply Agreement between the City and County of San Francisco and Wholesale Customers in Alameda County, San Mateo County, and Santa Clara County

(The cost increase of the Amendment to all Regional Water System customers would result in an increase of no more than \$0.04 per hundred cubic feet of water. There is no anticipated cost impact as a result of

adopting the Tier 2 Drought Response Implementation Plan.)

Deputy Public Works Director Flanagan introduced Danielle McPherson from Bay Area Water Supply and Conservation Agency (BAWSCA). Ms. McPherson reported that there are two identical actions are being proposed for the City and Guadalupe Valley Municipal Improvement District (GVMID); first, the adoption of a new Tier 2 Drought Response Implementation Plan (DRIP), and the revision of requirements in the WSA that impose Minimum Purchase Quantities (MPQ) on certain members of BAWSCA.

After Council questions, Paul Bouscal asked whether the flushing program is included in the allocation of water usage.

After Council discussion, Councilmember/GVMID Boardmember O'Connell made a motion, seconded by Councilmember Davis, to approve the following actions and the motion was carried unanimously by all present:

WSA Amendment Action:

1. Approve the revisions included in the attached Exhibit A, to be incorporated into a revised Water Supply Agreement titled the "2025 Amended and Restated Water Supply Agreement Between the City and County of San Francisco Wholesale Customers in Alameda County, San Mateo County, and Santa Clara County" dated as of 2025 (2025 Amended and Restated Water Supply Agreement).
2. The Chair of the Board is authorized and directed to execute the 2025 Amended and Restated Water Supply Agreement, when final execution copies are prepared and distributed by BAWSCA.

Tier 2 Plan Action:

1. Approve the Tier 2 Drought Response Implementation Plan, as attached as Exhibit A (Tier 2 Plan).
2. This approval is conditioned upon all of the other twenty-five Wholesale Customers approving the Tier 2 Plan, such approvals being evidenced through adoption of similar resolutions or, in the case of private-sector organizations, by other equivalently binding written commitments signed by an executive officer acting with in the scope of delegated authority, and all such approvals occurring on or before December 31, 2025.

O. Receive Report on City of Brisbane Volunteer Initiatives and Provide Direction to Staff

Assistant City Manager Fernandez reported that Staff recommends that the City Council discuss the types of volunteer activities it wishes to include in a comprehensive volunteer program that includes both outward and internal facing tools such as volunteer intake forms, a volunteer repository, volunteer waivers to ensure a robust volunteer base in Brisbane.

After council questions, Michele Salmon commented that volunteers need waivers to help maintain trees in private properties. And she also reminded Council that San Bruno Mountain Watch hosts businesses for volunteer opportunities all across San Bruno Mountain.

Councilmembers suggested volunteer opportunities such as plogging Crocker Park Trail, sports fields maintenance, red curb painting, sidewalk/street adoption program, and incorporating business volunteer programs and older adults into this initiative.
